Adoption of a Catechism: What we believe matters

Leadership of the Mid-Texas conference is excited to announce that the Global Methodist Church's Transitional Leadership Council (TLC) adopted a catechism for the new denomination on Monday, August 1, 2022. The Catechism working group was led by Dr. Jason Vickers, Professor of Theology at Asbury Theological Seminary (Wilmore, Kentucky) and included a 10-member group including clergy, laypeople and teachers from around the world. Knowing what we believe and why is critical to developing deeply discipled Christians. "In these challenging times, the desperate need for a high level of catechesis – the teaching and learning of the Christian faith – is extremely important for those longing to be obedient disciples of Jesus Christ," said Bishop Emeritus Mike Lowry, a member of the TLC and a leader in the Global Methodist Church. "I am confident people of all ages and stages of faith development will benefit from the catechism we have adopted. It is a gift to the whole Church, and all of us will be strengthened through both a heart and head commitment in reclaiming the life-giving confessions of our faith."

Mid-Texas Provisional Annual Conference in Formation

Persons from the North Texas, Central Texas, and Rio Texas areas sit on the *Mid-Texas Transitional Conference Advisory Leadership Team (TCAT)*. The TCAT is the legal incorporating body, forming the transitional boards for the annual conference, including the Board of Ministry. This body approves congregations and clergy

seeking to join the Global Methodist Church in the Mid-Texas geographic area. They will ratify the work of the Presiding Elders in approving appointments. The names of these leaders will be made after the September 17th Central Texas UMC Disaffiliation Conference. Rev. Dr. Leah Hidde-Gregory, Mid-Texas GMC Organizer has been assigned the President Pro-Tem for the Mid-Texas Provisional Annual Conference effective November 1, 2022.

An Update from the North Texas Conference

As of this week we are aware of more than 40 churches that have started the disaffiliation process. God is certainly making away for these churches! Please continue to keep them in your prayers.

Zero Pension Liability in the Central Texas Conference

We celebrate the Announcement on Friday July 29th from the Central Texas Conference of the United Methodist Church. The Mid-Texas GMC leadership is very grateful to the faithful negotiating partners we had with conference leadership. After a quarterly valuation of pension liability and adjustments made by Wespath, along with the annual conference action to utilize reserves to offset costs, the Pension liability was reduced to \$0. To God be the Glory! There will still be exit costs to the local church. You must pay last year's apportionments and this year's apportionments in full along with other legal expenses. Church Planting Initiative

The GMC recently announced a strategic multiplication alliance with The River Network. The River Network is led by a team composed of church multiplication specialists from various tribes in the Wesleyan theological family. They have years of experience in assessing, training, mentoring, coaching, and deploying church planting teams globally. Working with The River Network, the Global Methodist Church will respond to the immediate opportunity to plant new churches in communities where there is no theologically conservative Methodist presence as well as respond to circumstances where there are groups of Christ-followers who are leaving existing churches because of theological division and conflict.

The Network will focus on the following:

- Cultivating a mindset and culture of multiplying disciples, leaders, and churches.
- Training, equipping, and assessing laity and clergy who are called to be church planters.
- Mentoring and coaching church planting teams as they are deployed.
- Serving as a "midwife" for the birth of new churches, including creating an environment that inspire new planters. With encouragement and training the Global Methodist Church is convinced there are people ready to step away from local churches where they no longer feel welcome in order to plant new churches in their communities.

Connectional Funding in the Global Methodist Church Set at 2% in Transitional Time

The Transitional Leadership Council (TLC) established the percentage of local church annual operating income that will be used in calculating connectional funding contributions for general church and annual conference operations. A recent article, Connectional Funding in the Global Methodist Church, provided important information about this topic. While paragraph 349.4 of the Transitional Book of



Doctrines and Discipline establishes ceilings above which connectional funding percentages cannot go, the TLC had not set those percentages until now. Local churches are being asked to contribute one percent of their annual operating income for general church connectional funding, 33 percent less than the ceiling of 1.5 percent. In addition, local churches are asked to contribute one percent of their annual operating income for annual conference connectional funding, substantially less than the five percent ceiling set by the *Transitional Book of Doctrines and Discipline*. Annual operating income is determined by the local church treasurer and ¶ 349.1-3 defines that process. As the TLC has previously announced, local churches may apply for relief from these connectional funding percentages during the period prior to the convening General Conference. The Council is mindful of the burden many local churches are bearing as they pay significant disaffiliation fees to the UM Church in order to align with the Global Methodist Church. The TLC plans to grant such applications liberally and permit local churches to decide the amount they are able to contribute for connectional funding.

Pension and Health Insurance Will Be Available through Wespath for Clergy and Lay Staff

The Global Methodist Church is happy to announce it has finalized negotiations with Wespath. The latter will administer the pension, and health, life, and disability insurance plans for the new denomination. GM Church clergy who are appointed at least half-time or more to serve local churches are already making contributions to the denomination's Covenant Retirement Plan.

Under the Covenant Retirement Plan, local churches contribute five percent of the pastor's compensation (i.e., salary plus housing allowance or the benefit of a provided parsonage). In addition, the clergyperson can make a personal contribution up to the IRS maximum for 403(b) plans in any given year. In 2022, the maximum amount is \$20,500. Local churches will match up to an additional five percent of a clergy person's contributions on a percentage for percentage basis. Lay employees of local GM churches may also participate in the Covenant Retirement Plan. However, the amounts a local church and a lay employee contribute may be different from the retirement benefit provided for clergy depending on the plan options chosen by the local church. Full details on the Covenant Retirement Plan will be published on the GM Church's website in the near future.

The Global Methodist Church's health insurance plan will be available to all full- and three-quarter-time clergy under appointment to Global Methodist local churches beginning January 1, 2023. Lay employees will also be eligible to be covered by the denomination's health insurance program under certain conditions specified by the

plan. Details on life and disability insurance benefits available to clergy under appointment will also be shared in the coming weeks.

What about Gap Healthcare Coverage From November to January?

The effective date of Disaffiliation is November 1st and the health coverage for the GMC does not begin until January 1st. This has left some people asking about GAP Coverage for Clergy and Lay Staff. Information Directly from the Wespath website helps alleviate the fears of being without coverage. For more information about remaining on the CTCUMC plan for November and December, reach out to your Benefits Administrator or directly to Wespath.



From Wespath's website: If a local church participates in the HealthFlex Plan through its annual conference and the local church separates/disaffiliates from the UMC, what happens to the HealthFlex coverage for clergy

and lay employees of the local church? The local church's participation in HealthFlex will cease on the effective date of the separation/disaffiliation because, at that point, the church is no longer affiliated with a HealthFlex plan sponsor, i.e., its annual conference. Clergy members who remain with the separated/disaffiliated church and lay employees of the church will lose active coverage on the last day of the month in which the separation/disaffiliation is effective. Those individuals and their covered family members will be eligible for 18 months of continuation coverage. The clergy member or lay employee, as applicable, would be required to pay 100% of the cost of continuation coverage.

How Clergy Transfer into the Global Methodist Church

If your Church has Disaffiliated, Submit Paperwork Now with a November 1st Effective Date

Once your church has had their disaffiliation conference with the District Superintendent or Presiding Elder, you may submit your paperwork to the Global Methodist Church. Note this should be BEFORE you submit anything formal to your District Superintendent or the Central Texas Annual Conference of the United Methodist Church.

Once you have completed your application, you may email it to apleasants@globalmethodist.org or to info@globalmethodist.org. In your cover letter, please explain that your church will officially be released from the Central Texas Conference effective November 1, 2022 and that you are seeking to have your credentials recognized on that date in the Global Methodist Church. How Churches Affiliate with the Global Methodist Church

Once your church has voted to disaffiliate from the United Methodist Church formally with the United Methodist District Superintendent or Presiding Elder present, you may have the vote to approve the motion to affiliate with the Global Methodist Church. This vote should be chaired by the Administrative/Council Chair of the Congregation, after the departure of the UMC DS or Presiding Elder. It is a vote outside of the official Disaffiliation Conference.

The suggested motion provided by the Global Methodist Church is:

"I move that _____ Church become a member congregation of the Global Methodist Church, that it affirms and endorses the doctrinal standards (Part One), Social Witness (Part Two), and church governance of the Global Methodist Church as set forth in its Transitional Book of Doctrines and Discipline, and agrees to be accountable to such standards, witness, and governance. Our leadership and trustees are authorized to take all actions necessary to implement this motion."

*This is a standing vote of professing members with a majority vote.

Once the vote has occurred, please email the minutes from the meeting to <u>apleasants@globalmethodist.org</u> or <u>info@globalmethodist.org</u> In the cover letter, request that your congregation be recognized as of November 1, 2022.
