# REPORT OF THE TRANSITIONAL LEADERSHIP COUNCIL TO THE CONVENING GENERAL CONFERENCE

The Transitional Leadership Council (TLC) was formed in March of 2020 in anticipation of the Protocol of Reconciliation & Grace Through Separation (the "Protocol") being adopted at the 2020 General Conference of The United Methodist Church (UM Church). The TLC was originally chaired by Rev. Keith D. Boyette and was composed of 18 persons from around the world. The initial membership of the TLC was the result of input from leaders of the Confessing Movement, Good News, the Wesleyan Covenant Association, and UM Action, as well as nominations from evangelical, orthodox leaders not aligned with those organizations. Additionally, the TLC was structured so that its members were drawn from every geographical region of Methodism. The assignment of the TLC was to stand up a theologically conservative church committed to the orthodox confession of the Christian faith in the Wesleyan tradition.

The 2020 General Conference of the UM Church was ultimately postponed three times because of the Covid pandemic. When the last postponement was announced, the TLC made the decision to launch the Global Methodist Church effective May 1, 2022, rather than endure the continuing uncertainty associated with the holding of the UM Church General Conference and the widespread disobedience to the order and discipline of the UM Church.

During the period from March of 2020 to April of 2022, the TLC adopted the provisions of a *Transitional Book of Doctrines and Discipline* to govern the GM Church from May 1, 2022, until a convening General Conference was held. The TLC established a general church leadership structure for the transitional period and developed policies and procedures to govern the church in its early days. The TLC appointed the Rev. Keith Boyette as the Transitional Connectional Officer, its chief executive and administrative officer, the Rev. Walter Fenton as the Deputy Connectional Officer, and the Rev. Angela Pleasants as the director of clergy and church relations. Rev. Leah Hidde-Gregory became the chair of the TLC in June of 2022. As it began operations, the GM Church received a gift of \$1,000,000 from the Next Methodism Fund of the Wesleyan Covenant Association.

The TLC authorized a website, <u>www.globalmethodist.org</u>, and a weekly e-newsletter, Crossroads. Beginning on May 1, 2022, the TLC began to receive churches and clergy into membership in the GM Church. Consistent with the *Transitional Book of Doctrines and Discipline*, the general church staff was kept to the minimum necessary for the operation of the general church. The TLC established that general church operations would be funded by connectional funding set at 1% of each member church's prior year operating income. The TLC provided oversight for the churches as they joined, credentialed clergy, and appointed them to serve specific local churches. The TLC authorized pension and benefit plans to be offered through Wespath.

Under the direction of the TLC, processes were developed to form provisional annual conferences in defined geographical regions globally. The TLC authorized the formation of Transitional Conference Advisory Teams (TCATs) and, through the general church staff, guided such teams in forming provisional annual conferences. In each instance, the TLC determined when a provisional annual conference was authorized to begin operations. By the fall of 2022, the first provisional annual conferences began operations, being led by presidents *pro tempore*.

The TLC provided oversight to and accountability for the general church staff and approved all expenditures of general church funds. The TLC also supervised and approved efforts of the general church staff to respond to requests to form provisional annual conferences outside the United States.

Additionally, in the fall of 2022, the TLC began to form four transitional commissions – Evangelism, Missions, and Church Planting; Discipleship, Doctrine, and Just Ministry; Ministry and Higher Education; and Finance, Administration, Pensions, and Benefits. The TLC provided oversight for these commissions and encouraged the development of ministries to support and resource local churches through them. In addition, the TLC received applications from and approved a list of recommended educational institutions for the GM Church.

The TLC authorized and ultimately approved a Catechism for the Global Methodist Church. The TLC has also approved relationships with MinistrySafe for services to protect children, youth, and vulnerable adults, which is offered to local churches at no additional cost. The TLC also approved a contractual relationship with Mission Insight, which offers demographic analysis at no cost to local churches.

In October 2022, Cara Nicklas became the chair of the TLC. Mark James Webb and Scott Jameson Jones were received as active bishops of the GM Church in January 2023. Additionally, the TLC approved receiving Young Jin Cho, Robert Hayes, Mike Lowry, and Edward Williamson as Bishop Emeriti of the GM Church.

In the spring of 2023, the TLC directed that the GM Church would hold its convening General Conference in the fall of 2024, and appointed a Transitional Commission on the Convening General Conference. Thereafter, the TLC provided direction and supervised the work of the Commission.

In the fall of 2023, in cooperation with the International Leadership Institute, the TLC received training and introduced the HistoryMakers Leadership Training to the provisional annual conferences. Many of the conferences are now offering this training to leadership groups.

From the fall of 2023 through May of 2024, the TLC developed and finalized legislative proposals to be submitted to the convening General Conference. The TLC has served as the body to which appeals are taken with respect to matters related to the convening

General Conference. Additionally, the TLC terminated the relationship with Wespath and authorized the offering of pension and benefit plans for clergy and lay employees administered by GuideStone.

As of September 1, 2024, the GM Church consists of 36 operating provisional annual conferences globally with three more soon to begin operations. The church's membership consists of 4800 local churches and 5500 clergy, with a significant number of churches and clergy in Africa currently filing applications to be received.

The TLC has established a goal of ending decades of financial dependency of some geographic areas of the church on other areas. The TLC has developed systems which will move every region of the church to self-sustainability, and that is developing a system of partnerships among annual conferences with financial resources with annual conferences that historically have been dependent on others for financial resources.

The fiscal year of the GM Church runs from July 1 to June 30. The financial status of the church at June 30, 2023, and June 30, 2024 is set forth on the attached unaudited financial statements which are currently being audited. While the GM Church currently has significant undesignated reserves at the general church level, a significant portion of these reserves will be necessary to pay expenses of the convening General Conference. Nevertheless, the GM Church is well positioned financially as it moves from its transitional phase into a more established season of its life.

The members of the TLC never thought they would be responsible for stewarding the GM Church in its formational and transitional period that has lasted more than four years. The members of the TLC have served sacrificially without remuneration throughout this period faithfully meeting virtually weekly for 60 to 120 minutes. They are eager to turn the responsibilities of leadership over to those entities approved for formation by the convening General Conference and to the persons who are then elected to leadership.

Presently, the legislation which will form the new general church leadership bodies specifies that it is not effective until January 1, 2025. This is necessary because of the time it will take to stand up these new connectional bodies with full membership assigned to them. During the period from the adjournment of the convening General Conference on September 26, 2024, through December 31, 2024, the TLC will continue to provide leadership for the GM Church under the *Book of Doctrines and Discipline* adopted during the opening plenary session of the convening General Conference. As they have to date, they will be careful stewards of this new church, ensuring that the decisions of the convening General Conference are implemented effective January 1, 2025. At that point, the members of the TLC will end their service, and the TLC will become part of the history of the GM Church.

We append to this report a list of the persons who have served or currently serve on the TLC.

Each of the members of the TLC would declare that serving in the birth and development of the GM Church has been one of the greatest honors of lifetimes of ministry. They are grateful for the opportunity. They praise God for His faithfulness and the miracles He has wrought in the creation of the GM Church. They joyfully join in the work with thousands of others that will help the GM Church fulfill its mission of making disciples of Jesus Christ who worship passionately, love extravagantly, and witness boldly.

# THE CONVENING GENERAL CONFERENCE COMMUNITY:

# Plan of Organization and Covenant for Our Life Together

### **PREFACE**

Following the biblical admonition in Hebrews 12:15 and elsewhere, John Wesley early on encouraged his followers to "watch over one another in love," first meeting with his brother Charles and a few other clergy in 1744 to consider "how we should proceed to save our own souls and those that heard us." (Transitional Book of Doctrines and Discipline (TBDD), ¶601). As the spiritual heirs of that tradition, our goal is still to peacefully work together for the common good of all in fulfilling the mission of the church. As members of the church of Jesus Christ, we also aspire to follow the leading of the Holy Spirit in our conferencing (Acts 15:28) and conform to God's will by experiencing God's transforming grace (Romans 12:2). Within the community of the General Conference, thus, the following are established to spell out how we can best respond in obedience to God's will and go about our mission, while still caring for all and making a bold witness for Christ to the world.

### **PLAN OF ORGANIZATION**

### I. OPENING SESSION

The Global Methodist Church will hold its Convening Conference in the place and time recommended by the Commission on General Conference and set by the Transitional Leadership Council (TLC), beginning with a time of worship. The Conference will then be called to order by a bishop designated by the TLC, with the following order of business:

- Recognition of delegations and delegates by the Transitional Connectional Operating Officer. The official roll call will be completed by the registration process.
- 2. Establishment of the voting bar of the Conference.
- 3. Report of the Commission on the General Conference.

- 4. Adoption of the Plan of Organization and Covenant for our community life as a Conference by a two-thirds vote. Prior to adoption, the Plan and Covenant may be amended from the floor by a majority vote.
- 5. Election of the General Conference Secretary upon nomination of the TLC (¶605.2, Plan IV).
- 6. Adoption of the Transitional Book of Doctrines and Discipline (TBDD) as the starting document outlining the governing principles and systems of the Global Methodist Church, subject to all amendments and additions as approved by the convening General Conference. At the end of the conference, the Book of Doctrines and Discipline will be adopted as amended by majority vote and will no longer be considered "transitional."
- 7. Adoption of the proposed limited agenda of the Convening Conference including worship services, special presentations, and specific paragraphs in the TBDD which are open to amendment or change as spelled out below. Additional paragraphs or topics may be considered by a two-thirds vote of the General Conference delegates.
- 8. Miscellaneous business

### **II. PRESIDING OFFICERS**

All plenary sessions of the General Conference will be guided by the active and bishops emeritus of the Global Methodist Church, as assigned by the Committee on Agenda (¶ 605.1). Legislative Committees will be convened by one of the bishops in order to elect a chair, vice-chair, and secretary, who will then preside over committee meetings (see below).

### III. COMMISSION ON THE GENERAL CONFERENCE

Prior to the convening conference, the TLC will have appointed a commission to oversee the preparations and recommend the optimal time and place for the conference. The Commission will also recommend to the TLC the total number of delegates, as well as recommend the formula for the equitable allocation of delegates to the entire global church and coordinate logistical arrangements for the successful operation of the Conference.

### IV. THE SECRETARY OF THE GENERAL CONFERENCE

Prior to the General Conference, the TLC will appoint an acting Secretary. At the opening session of the General Conference, the TLC will nominate and the delegates will elect the Secretary of the General Conference. The Secretary will be accountable to the Commission on the General Conference, working closely with the presiding bishops and the TLC. The Secretary, assisted by volunteer or paid staff, will be

responsible for implementing the daily agenda and for coordinating the work of the legislative committees in dealing with petitions and resolutions. Working with the Commission on the General Conference, the Secretary will initiate procedures to prepare all delegates for full participation in the General Conference by providing information concerning both the operation of the General Conference and materials it will consider. In addition, the Secretary will oversee the work of the administrative committees of the General Conference, serving as an ex officio member as indicated below. This position may be a paid staff position. If the position of Secretary becomes vacant in between General Conference sessions, the Connectional Council will elect a successor to serve until the next session.

### V. COMMITTEES OF THE GENERAL CONFERENCE

### A. ADMINISTRATIVE COMMITTEES

- 1. An **Agenda Committee** will be composed of eight delegates, half clergy and half lay from across the global church, as well as the chairs of each legislative committee and the Secretary of the General Conference who will be an *ex officio* member. The Committee will prepare the daily order of the plenary sessions, including the consideration of those petitions identified by each legislative committee as having the highest priority for conference action. They will also select the presiding officer for each plenary session. The agenda will be set in such a way as to rotate through each committee one such priority item at a time, with the allowance that related petitions within one area may be considered at the same time. The Committee will announce at the close of each plenary session a tentative agenda for the subsequent session.
- 2. A **Credentials Committee** will be composed of eight delegates, half clergy and half lay from across the global church who will consult with the Secretary of the General Conference and decide on all matters dealing with the approval of credentials and the seating of delegates.
- 3. A **Reference Committee** will be composed of eight delegates, half clergy and half lay from across the global church, who will refer all petitions and resolutions received to the appropriate legislative committees.
- 4. A **Courtesies Committee** will be composed of eight delegates, half clergy and half lay from across the global church, who will consider resolutions of commendation, courtesy, or appreciation submitted by delegates for presentation to the plenary session, as well as special guests who may be invited to address the conference.
- 5. A **Journal Committee** will be composed of three delegates, plus the Secretary of the General Conference, who will approve the daily proceedings, as well as reconcile all petitions which are passed by the Conference with other provisions within the TBDD.

6. A **Nominations Committee** will be composed of eight delegates, half clergy and half lay from across the global church, who will nominate a slate of persons to serve as members of the various general church commissions and councils.

### **B. MEMBERSHIP OF ADMINISTRATIVE COMMITTEES**

Members of Administrative Committees will be nominated by each delegation at least 60 days prior to the conference and elected by the TLC out of the pool of nominees for the convening General Conference, taking care to ensure representation across the geographical areas of the church. For subsequent General Conferences, nominations will be made to the Connectional Council for their election. Membership on an Administrative Committee does not prevent the person from serving on a Legislative Committee.

### C. LEGISLATIVE COMMITTEES

Seven legislative committees will be established for the Convening General Conference, each composed of no more than sixty-five persons, as nearly as possible half lay and half clergy from across the global church, with a minimum of thirty persons for each committee. The convening General Conference will have a limited agenda in order to allow time for the most significant decisions to be made affecting the development of the Global Methodist Church and to allow more input at the subsequent General Conference from congregations and areas across the world that may not yet be an official part of the GMC. Petitions related to paragraphs not listed in the limited agenda below will be referred to the next General Conference for consideration, unless by a two-thirds vote the conference agrees to take them up. Such petitions will not be translated before the convening General Conference. The petitions secretary appointed by the Transitional Leadership Council will publicly report the disposition of each submitted petition, along with the rationale for its disposition (accepted, not accepted, referred).

In addition to the agenda listed under each legislative committee, the General Conference agenda will include the ability of any legislative committee to recommend forming working groups or task forces to develop proposals for a future General Conference. The agenda will also include the ability to pass petitions that make editorial changes to parts of the *Transitional Book of Doctrines and Discipline* that are not otherwise considered part of the agenda. Such editorial petitions do not open those non-agenda paragraphs to other amendments without the two-thirds vote of the General Conference.

- 1. The **Conferences Legislative Committee** will establish or approve the boundaries and names of annual conferences, as well as the formula allocating delegates to the General Conference and the possibility of the creation of regional conferences. It will review petitions relating to the following paragraphs within the *TBDD*: 522, 523, 604, 609, 612, 613, and Part 6 editorial.
- 2. The **Connectional Organization Legislative Committee** will consider the process for nominating officers for the General Conference, as well as the establishment and work of ongoing commissions. It will review petitions relating to the following paragraphs within the *TBDD*: 605, 607, and all of Part 7 (including editorial).

- 3. The **Constitution Legislative Committee** will oversee the writing of a constitution for the Global Methodist Church for presentation and adoption by the General Conference. It will review petitions relating to the following paragraph within the *TBDD*: 301 and Parts 1 and 2 editorial.
- 4. The **Episcopacy and Superintendency Legislative Committee** will consider matters such as the question of a general or residential superintendency, episcopal compensation, the process for the election and assignment of bishops, including term limits, episcopal area boundaries, and the establishment of a Global Episcopacy Committee. It will review petitions relating to the following paragraphs within the *TBDD*: 502, 503, 504, 505, 509, 510, 511, 512, 513, 514, 515, 516, 517, 518, 519, 521, and Part 5 editorial.
- 5. The **Financial Administration Legislative Committee** will give oversight to connectional funding matters and caps, delegation of budgeting to the Connectional Council, as well as implementing the Ministerial Training Fund. It will review petitions relating to the following paragraphs within the *TBDD*: 349, 411, and Part 9 editorial.
- 6. The **Judicial Administration Legislative Committee** will revise paragraphs relating to complaints against clergy and bishops, assigning responsibility to conference boards of ministry and a Global Episcopacy Committee, as well as revise the *Judicial Practices and Procedures* referred to in **9**802. It will review petitions relating to the following paragraphs within the *TBDD*: 520 and all of Part 8 (including editorial).
- 7. The **Ministry and Local Church Legislative Committee** will consider the educational requirements for ordination, create a mechanism to ensure that ministry candidates can be voted upon individually rather than in a block, revise procedures for the approval of chaplains and evangelists, define the membership standards, and designate the body responsible for upholding congregational fidelity. It will review petitions relating to the following paragraphs within the TBDD: 322, 354, 355, 407, 409, 410, 413, 414, 419, and Parts 3 and 4 editorial.

### D. MEMBERSHIP ON LEGISLATIVE COMMITTEES

Within each annual conference delegation, each delegate may indicate their first, second, and third preferences for which legislative committee on which to serve. Membership of each legislative committee will be determined by the Transitional Commission on the Convening General Conference or its designee, based on the preferences of the delegates, the minimum and maximum number of committee members, and the need for geographical diversity.

### E. PROCEDURES FOR LEGISLATIVE COMMITTEES

1. **Pre-Conference Meetings**—Legislative committees may meet virtually during the 90 days prior to the Convening General Conference to begin work on petitions and topics assigned to them. The work of legislative committees meeting prior to the convening of the General Conference must be completed seven days before

- the opening session. The first virtual meeting of a legislative committee will elect officers, introduce members to one another, and set the agenda for their preconference meetings.
- 2. Committee Officers—The initial meeting will be presided over by an active bishop or bishop emeritus. Subsequent meetings will be presided over by the elected committee officers. Each committee will elect from within its membership a chair, vice-chair, and secretary, as well as any subcommittee officers if such are needed. Election is by simple majority, and it is hoped that leadership will be reflective of the global and diverse nature of the church. The Transitional Commission on the Convening General Conference will provide training to the legislative committee officers once they are elected and prior to the committees beginning any subsequent virtual meetings.
- 3. Parliamentarians—To the extent possible, each legislative committee will have a volunteer parliamentarian who will not be a General Conference delegate. The parliamentarians will attend all committee meetings, including virtual meetings in advance of the convening of General Conference, and advise the committee on the implementation of the Covenant for Our Life Together and parliamentary procedure. Additionally, this person may train the committee members on basic committee procedures.
- 4. Initial Meeting Introductions—Each member of the legislative committee must submit his/her written introduction to the General Conference secretary's office not later than 72 hours before the initial scheduled committee meeting. This written introduction should include a picture, a brief summary of their history with the church, and areas of interest, experience, and expertise. The introduction should also indicate the person's interest in standing for election as a legislative committee officer. The secretary's office will then send the written introductions of all the members to the committee prior to its initial meeting. At the start of the initial meeting of the committee, each committee member will introduce themselves by giving their name, place of residence, lay or clergy status, and provisional annual conference or district.
- **5. Quorum**—A quorum is required for any legislative committee discussion or action on any item of business. One-half (1/2) of the membership of the committee constitutes a quorum in order to conduct business. A calling of the committee roll will occur before each committee may begin their business. A record of those present and absent is announced for the committee record at the start of each meeting by the chairperson or his/her designee. Proxy voting is <u>not</u> allowed.
- 6. Setting Meeting Days—The date and time of any initial meeting of each legislative committee will be established by the Transitional Commission on the Convening General Conference or its designee based on polling of members' availability. Subsequent to such an initial meeting, legislative committee officers will set the dates and times of any subsequent virtual meetings. Every effort will be made to ensure global participation in virtual legislative committee meetings.

Members will be notified of such committee meetings at least 72 hours in advance. If circumstances dictate, a special virtual meeting may be called by the chair or by a majority of the members, in which case the 72-hour notice must be waived by a two-thirds electronic vote of members prior to the meeting. Notification of meeting times and dates will be conducted via electronic means. If a delegate is unable to attend a legislative committee meeting, the head of the delegation should ensure that an alternate delegate attends in their place. Once the General Conference has convened, the agenda committee will determine committee meeting dates and times.

- 7. Agenda—The virtual meeting notification will include a written agenda together with any materials prepared by the staff or others relating to that agenda. After the agenda for a committee meeting is published and distributed, no non-germane items (as determined by the chair) may be brought up during that meeting unless at least two-thirds of the members present agree to consider those items.
- 8. Effect of Pre-Conference Actions—All actions of a legislative committee during virtual meetings prior to the General Conference are to be considered provisional, with the exception of the officers elected by the committee. When the legislative committees meet at the site of the General Conference, their first act of business should be to ratify the actions taken during pre-conference meetings. Each petition that is modified or proposed by the legislative committee should be ratified individually as finally modified or proposed. Such ratification does not preclude additional subsequent changes to the petition during the conference. Any modified petition that is not ratified will revert to its original form.
- 9. Bringing a Matter to a Vote—If the chair determines that a motion, petition, or amendment has been adequately debated, he/she may call for a vote on such petition, motion or amendment, and the vote will then be taken, unless the committee votes to continue debate. The vote on a motion to continue debate on any petition, motion, or amendment will be taken without debate. This motion to continue debate must occur prior to the vote on such petition, motion, or amendment, if presented in a timely manner. A majority affirmative vote is required to continue debate. Members on their own initiative may by a two-thirds vote end debate and proceed to act on a motion, petition, or amendment (call the question).
- **10. Public Announcement of Votes—**The results and vote totals of votes taken by the committee on any non-procedural measure, petition, or motion (or amendment thereto) must be announced publicly at the time of the vote and reported to the secretary of the General Conference for presentation to the plenary body.
- **11. Open Committee Meetings**—To the extent possible both in-person and virtual meetings of the legislative committees will be open to the public.

### 12. Minutes of Committee Meetings

a. An accurate record must be kept of the committee's actions, in the form of minutes. These minutes, and where applicable, a minority report, should be submitted to the secretary of the General Conference within 24 hours of a

virtual meeting and by 10 PM on the day of the meeting at the site of General Conference. In addition to written minutes, the committee must make available a video or audio recording of any virtual meeting and copies of any materials offered during debate in the committee. The committee written documents will remain available on the denominational website, and electronic versions of any documents, petitions, or motions made or used throughout the General Conference will remain on the denominational website as archived for historical value and their legislative history value.

- b. The work of the legislative committees meeting prior to the convening of the General Conference should be posted on the denominational website as the work progresses. That work should end seven days before the convening of the General Conference. All work done by legislative committees prior to the General Conference will be compiled into a printed Pre-Conference Workbook available to delegates electronically and in print the day before the opening session.
- c. During the convening General Conference, any further changes made to petitions or topics assigned to legislative committees will be updated to the website and printed in the daily Conference Journal given to delegates each morning at the start of business.
- d. All versions will remain in the archives of the denominational website to preserve their historical and legislative historical value.

### VI. NOMINATIONS AND ELECTIONS

The Convening General Conference will elect members to serve on the following committees and commissions individually by majority vote, upon nomination by the Nominations Committee. Membership on a commission or council is not limited to General Conference delegates.

1. Nomination Process. Provisional Annual Conferences (acting in session or through their primary legislative body) will be encouraged to submit nominations and resumes to the Committee at least 45 days prior to the General Conference. In addition, individuals interested in serving on one of these bodies may directly submit their names and resumes to the Committee at least 45 days prior to the General Conference. The Nominations Committee will funnel the names of potential individual nominees to the relevant Provisional Annual Conference or District Nominations Committee for vetting before being considered (if those names were not submitted by a PAC or PD). Each nominee may submit a brief biography of up to 100 words, which will be printed along with the nominee's name in any published slate of nominees.

- 2. Representation. The Nominations Committee will take care to consider geographical, racial/ethnic, gender, and age diversity in the makeup of the committees and councils, while also prioritizing members' gifts and experience. In casting their ballots, General Conference delegates should be mindful of these same values.
- **3. Nominations Committee Process.** The Nominations Committee will publish a slate of nominees for each commission or council at least 20 days prior to the General Conference on the GC website.
- **4. Additional Nominees.** Once the Nominations Committee slate is published, additional persons may be nominated or may nominate themselves at least 10 days prior to the General Conference, including a 100-word biography. The Nominations Committee will vet these additional nominees with the appropriate PAC or PD if needed. The full slate of Nominations Committee nominees and additional nominees will be published in the Preconference Workbook available the day before the conference. Those nominated by the Nominations Committee will be indicated by an asterisk.
- 5. Additional Members. Within ninety days following the election of the councils or commissions, the Connectional Council is empowered to add additional members to any of the councils or commissions, including itself, in order to ensure both diversity and expertise if needed. The number of additional members may not exceed twenty percent of the membership of the council or commission. Respecting the need to preserve the balance between the seven lay and clergy members who rotate majorities each six years, the Connectional Council on Appeals shall not be subject to this provision for additional members.
- **6. Council and Commission Officers.** Each committee, commission, or council will elect its own chairperson and such other officers as it deems necessary from among the members of the body.

### 7. Councils and Commissions to Be Elected.

- a. Connectional Council
- b. Connectional Commission on Discipleship, Doctrine, and Just Ministry
- c. Connectional Commission on Evangelism, Church Multiplication, Missional Mobilization, and Disaster Response
- d. Connectional Commission on Ministry and Higher Education
- e. Connectional Commission on Communications
- f. Connectional Commission on Finance, Administration, Pensions, and Benefits
- g. Connectional Commission on Ecumenical Relationships
- h. Connectional Commission on Conferences
- i. Commission on the General Conference
- j. General Committee on Episcopacy Committee
- k. Connectional Council on Appeals (and alternates)

### VII. DELEGATE EXPENSES

Full travel, lodging, and *per diem* expenses for delegates who need it will be the responsibility of each provisional annual conference or district (through connectional funding, special fundraising, or other creative means), provided that the expenses of delegates from outside of the United States may be covered through the general church or by partnership arrangements with other conferences. Air travel will be arranged through the travel agency designated by the Transitional Commission on the Convening General Conference to allow for the most economical round-trip coach airfare directly to and from the site of the General Conference. Additional expenses may be allowed for delegates from conferences outside of the country where the General Conference meets for arrival and departure not to exceed two days before or after the General Conference is scheduled to meet. Delegates may pay their own expenses for food and lodging to extend their stay before or after the conference. When one or more delegates travel to the site of the General Conference in the same automobile, the owner will be reimbursed for the actual cost of travel, including parking, tolls, and mileage according to a standard amount announced by the Commission on the General Conference.

### VIII. DELEGATION ORGANIZATION

- A. Each delegation will identify its own delegation head by the means determined by the delegation or by its annual conference.
- B. The delegation head's responsibilities will include, but not be limited to, the following:
  - 1. Organize and orient the delegation, including alternates, to their responsibilities leading up to and during the General Conference
  - 2. Serve as the primary contact person between the general church and the delegates, including facilitating two-way communication
  - 3. Review with delegates the Plan of Organization and Covenant for Ordering Our Life Together of the General Conference
  - 4. Create a process to review and discuss legislative proposals coming before the General Conference
  - 5. Submit as requested delegate preferences for serving on legislative committees
  - 6. Facilitate the process for the delegation and the annual conference to submit nominations for general church councils and commissions
  - 7. Authorize the substitution of alternates in legislative and plenary sessions when appropriate, using the processes developed by the Credentialing team

### IX. MARSHALS, PAGES, AND PARLIAMENTARIANS

- A. The Transitional Commission on the General Conference or its designee will be responsible for recruiting and overseeing marshals, pages, and parliamentarians to serve at the conference site. Marshals and pages will serve as volunteers without compensation, except that a freewill offering of the delegates and visitors may be accepted to help defray their expenses.
- B. Marshals are responsible to provide order and security by ensuring that only authorized persons are present within the bar of the plenary or committee sessions of the conference. They may also assist in providing directions and otherwise safeguarding the orderly function of the conference.
- C. Pages are to be available to serve the delegates by distributing materials, serving as vote tellers (if needed), carrying communications, and running brief errands.
- D. Parliamentarians will be provided for both the plenary and legislative committee sessions. Such parliamentarians will not be General Conference delegates and will be volunteers. The budget for the General Conference will include providing for the expenses of the parliamentarians to attend and participate.

### **COVENANT FOR ORDERING OUR LIFE TOGETHER**

### I. DAILY SCHEDULE

The Agenda Committee will set the daily schedule and agenda, with all plenary and legislative committee meetings between the hours of 8:00 AM and 6:00 PM. A particular legislative committee or the plenary body may vote by two-thirds to hold an evening session in consultation with interpretation services.

### II. RIGHTS AND DUTIES OF DELEGATES

- 1. Definitions:
  - a. Delegate is a person elected by their annual conference to serve and be seated as a representative of that conference at the General Conference.
  - b. Alternate is a person elected by their annual conference to serve in the event that a delegate cannot attend or participate at the General Conference (including virtual meetings of legislative and administrative committees). The number of alternates is determined by the Commission on the Convening General Conference through a formula. Alternates are permitted to travel to the site of the General Conference and are credentialed to be seated at the discretion of the delegation head (see II.2).

- c. Reserve is a person next in order of election who will not be credentialed to travel to the site of the General Conference as an alternate but who could move up to alternate if needed. Reserves become alternates in order of election if a delegate or alternate resigns or is removed from the delegation or is otherwise incapable of serving for a significant period of time (determined at the discretion of the delegation head, with an appeal possible to the delegation). If a reserve is elevated to alternate due to a delegate or alternate's incapacity, that elevation will last only as long as the incapacity lasts.
- 2. Delegates and alternates will be seated in order of their election, except in the case of special need as determined by the delegation chair in consultation with the affected delegates. Alternates will occupy the seat of the delegate for whom the substitution is made. Alternates will not be seated for delegates presenting on the platform. Alternates chosen to be seated will be of the same order (lay or clergy) as the absent delegate.

#### III. PARLIAMENTARY PROCEDURES

- 1. Purpose. The purpose of this Covenant and Robert's Rules of Order is to provide a fair and orderly way for the General Conference to make decisions under the guidance of the Holy Spirit. Accordingly, neither this Covenant nor Robert's Rules should be used to block the body's ability to make decisions, to silence a minority perspective, or to disadvantage any person or group. Presiding officers should work toward consensus and seek to provide fair opportunities for all views to be heard. They should assist members of the body in understanding and applying the processes outlined in this Covenant for communal decision making and using them in that spirit.
- **2. Consensus**. Wherever possible, the Conference will strive for consensus decisions that embody the unity of the whole Church. Beyond such, as per ¶606, the convening General Conference will operate under *Robert's Rules of Order* and such supplemental rules as adopted by the Conference.
- **3. Quorum.** The convening General Conference requires the presence of a majority of the whole number of delegates to constitute a quorum for the transaction of business; but a smaller number may take a recess or adjourn from day to day in order to secure a quorum, and at the final session may approve the journal, order the record of the roll call, and adjourn *sine die* (¶606.2)
- 4. Consent Agenda. Petitions receiving the vote of 90 percent or more of a legislative committee may be placed upon a consent agenda for approval, disapproval, or referral at the beginning of each day, provided that an item may be removed from the consent agenda upon the motion of ten delegates.

- 5. Agenda. The Agenda Committee will recommend an agenda at the beginning of each day's business, which would then be adopted by majority vote of the body, with or without amendment. The Secretary of the General Conference will maintain and guide the agenda, which includes the orders of the day and the reports of committees. Business placed on the agenda will be considered in the order of the adopted agenda unless by two-thirds vote of the Conference an item is taken up out of order.
- 6. **Presenters**. Proposals supported by the vote of the legislative committee will be presented to the plenary body by the chair of the committee or his or her designee. If there is a minority report from the committee, that will be presented after the committee's report is presented but prior to action on the committee's motion (see Covenant III.14).
- 7. **Speaking**. Delegates wishing to speak must first be recognized by the presiding officer and unless raising a point of order or parliamentary inquiry, delegates may not speak unless given the floor. Delegates so recognized must begin by sharing their name, conference membership, and the reason for speaking, before beginning their speech. Delegates recognized by the presiding officer may not yield the floor to others to speak.
  - 7.1. The presiding officer should operate in a transparent way, taking care to consider the various sections of the meeting room, as well as the breadth of the global church, in calling upon speakers.
  - 7.2. Unless debate is extended by vote of the delegates, discussion on motions will be limited to three speeches for and three against the proposal, with each speech no longer than three minutes.
  - 7.3. No delegate may speak more than once on the same subject under the same motion unless responding to a question or misrepresentation. However, the chair or delegate presenting the petition or minority report is entitled to make closing remarks before the vote is taken for up to three minutes.
  - 7.4. The number limit and length of speeches may be modified by the body by majority vote at any time and for any duration.
- **8. Ending Debate.** The motion to call the previous question is not debatable but it is likewise not in order without an opportunity having been given for at least two speeches for and two against a proposal. The motion requires a two-thirds vote of those present and voting for its adoption.
- 9. Point of Order. A delegate wishing to raise a point of order may do so when recognized by the presiding officer and must first cite the rule involved and then state the point as briefly and concisely as possible. A point of order is decided by the presiding officer without debate unless submitted to the body for advice or decision. The ruling by the presiding officer may be appealed to the body, in which

- case only the presiding officer and the appellant may speak to the appeal before the vote is taken, with each speech no longer than three minutes.
- **10. Motions**. The right to make or second motions is restricted to voting delegates. Motions coming from a committee or commission do not require a second. All motions and amendments should be presented in writing to the secretary to ensure accurate wording.
- 11. Elections. A valid election occurs when the number of valid ballots cast for a nominee meets or exceeds the required percentage of the total valid votes cast. To be valid, ballots must contain votes for the same number of nominees as there are vacancies to fill, and no more than one vote may be cast for the same nominee, nor for individuals who have already been elected.
- **12. Voting**. Voting may be done by electronic ballot or show of hands.
  - 12.1. Delegates must be within the bar of the Conference in order to vote, and proxy voting for others is not allowed.
  - 12.2. If circumstances require that a vote be taken by show of hands, before or immediately after such a vote is taken, any delegate has the right to call for a count vote on any question. If electronic balloting is not available, a count vote would consist of a standing vote, with the pages acting as tellers. If electronic balloting is not available, a call for a secret ballot vote using paper ballots must be approved by majority vote, with the pages acting as tellers of the secret ballot vote.
  - 12.3. A simple majority of those delegates who are present and voting suffices to pass all motions with the following exceptions:
  - a. A non-delegate may be invited to address a legislative committee by invitation of the chair or a one-third vote.
  - b. A tie vote sustains the presiding officer.
  - c. A two-thirds vote is required:
    - i. To adopt, suspend, or amend the rules after initial adoption
    - ii. To adopt or amend the Constitution
    - iii. To set aside a special order of the day
    - iv. To sustain a call for the previous question
    - v. To consider business out of the order of the adopted agenda
    - vi. To consider business originally ruled as not within the parameters of the limited legislative agenda
    - vii. To hold a session outside the hours specified in this Covenant

- 13. Non-debatable Motions. The following motions will be acted upon without debate:
  - a. To adjourn, when unqualified, except for final adjournment
  - b. To suspend the rules.
  - c. To lay or remove a motion from the table.
  - d. To call for the previous question when in order.
  - e. To reconsider a non-debatable motion.
  - f. To limit or extend the limits of a debate.
  - g. To pause for prayerful discernment.
- 14. Substitutions and Minority Reports. Resolutions or petitions may be amended by substitution provided that the substitute is germane to the topic and an alternative to what is before the body and not simply a negation of the main motion. Substitute motions coming from a legislative committee minority would be in the form of a minority report, which is presented at the same time as the majority action of the legislative committee.
  - 14.1. The main motion or majority action of the legislative committee is presented first, followed by the presentation of the substitute. The main motion is perfected first by entertaining any proposed amendments. Then the substitute is perfected by entertaining any proposed amendments. Finally, the question is whether to adopt the substitute in place of the main motion.
  - 14.2. If the motion to substitute prevails by majority vote, the substitute motion becomes the main motion. If the motion to substitute fails to receive a majority vote, the original main motion remains pending until acted upon.
  - 14.3. Motions for the previous question are not in order on a motion to substitute until opportunity has been given for at least two speakers on each side of the question.
  - 14.4. Delegates wishing to offer a minority report must notify the chair of the legislative committee in writing within one hour (excluding breaks) of final committee action on the relevant petition. The notification of a minority report must be signed by five persons or ten percent of the legislative committee membership (whichever is less) who voted against the proposal, whose names and email addresses must be attached to the written request.
  - 14.5. Following notification (14.4), the delegates must submit the actual proposed wording of the minority report (see also Par. 14 introduction above) accompanied by a rationale up to 100 words. The minority report must be submitted by the printing deadline of the day following notification, unless that day is the last

day of the General Conference. If the following day is the last day of the General Conference, the minority report must be submitted as soon as possible, but no later than 10 PM on the day of notification, with the expectation that the report will be printed and distributed separately from the Daily Conference Journal, if necessary.

- **15. Reconsideration.** A motion to reconsider an action of the body is in order at any time if offered by a delegate who voted with the prevailing side. If the motion proposed for reconsideration was non-debatable, the motion to reconsider is likewise non-debatable.
- **16. Adjournment.** A motion to adjourn is in order when made by a duly recognized delegate and is not debatable. It is not in order when another delegate has the floor, when a question is pending or a vote is being conducted, when the previous question has been ordered and action is pending, when a motion to adjourn has been defeated and no business or debate has intervened, or when the motion to fix the time for the Conference to adjourn is pending.
- 17. Unfinished Business. All valid petitions submitted to the General Conference must be acted upon by a legislative committee (approve, disapprove, refer). All petitions approved by a legislative committee must be acted upon by the plenary session (approve, disapprove, refer).

#### IV. DECORUM AT THE GENERAL CONFERENCE

- A. Delegates and guests of the General Conference are expected to conduct themselves at all times in accordance with the biblical virtues of kindness, compassion, charitable conversation, and respect for all individuals as those who bear the image of God. Non-delegates are not allowed within the bar of the General Conference except by the approval of the voting delegates. Delegates are also expected not to distract others with cell phone usage during proceedings of the body or committee. Likewise, the use of social media to denigrate others is neither in keeping with the spirit of Christ or the spirit of the General Conference.
- B. Demonstrations designed to disrupt or delay the work of the Conference will not be allowed within the spaces where plenary sessions or committee meetings are being held, including virtual electronic meetings. The presiding officer of the affected meeting may use his or her discretion to have any who violate the decorum of the Conference, including those within the gallery, immediately removed from the assembly room or virtual meeting. Such removal covers only the current session unless there are repeated violations. The presiding officer's decision to expel a person may be overturned by a majority vote of the body. Marshalls may be asked to assist in the removal of such violator(s).

- C. Should there be undue tensions or anxieties affecting the work of the delegates, the presiding officer may also pause the proceedings of the Conference at any moment in order to have a time of prayer. For security reasons, sessions of the General Conference may be closed to non-delegates upon a two-thirds vote of the body. In such cases, the sessions should continue to be live-streamed, unless security reasons warrant otherwise.
- D. Distribution of materials that are relevant to the issues under consideration may be made outside of the bar of the Conference or a legislative committee provided that such distribution is done in a way that is respectful and non-invasive of the delegates' personal space or privacy. Distributors are responsible for the disposal of any unused or unclaimed materials.
- E. Distribution of non-legislative materials to the delegates within the bar will be allowed only upon the permission of the Agenda Committee. Distribution within the bar of legislative materials not part of the limited agenda, as determined by the petitions secretary and the Reference Committee, will be allowed only upon approval of a two-thirds vote of the delegates.

#### V. AMENDING THE PLAN AND COVENANT

Adoption of the Plan of Organization and the Covenant for Ordering Our Life Together at the beginning of the conference is by two-thirds vote, but amendments at that time only require a majority vote for approval. Subsequent to the initial adoption, the Plan and Covenant may be amended, changed, or suspended by a two-thirds vote of the General Conference. In any parliamentary situation not covered under this Plan or Covenant, the General Conference will be governed in its action by the current edition of *Robert's Rules of Order*.

# **2024 Legislative Process**

Petitions are submitted by church bodies, annual conferences, churches, or individual members.



Petitions Secretary and Petitions Committee determines if the petition is validly submitted and if it fits the limited agenda of the 2024 General Conference. Petitions are assigned to the appropriate legislative committee.



Valid petitions are published digitally online in all the official languages of the Church in the Pre-Conference Workbook. Petitions not fitting the limited agenda are named, but not published.



Legislative Committees meet virtually and act on petitions. They may affirm the petition (with or without amendments), reject the petition, or refer it to another body.



Results of virtual Legislative Committee meetings are compiled and printed in the Pre-Conference Workbook for the first in-person session of the General Conference.



First in-person Legislative Committee meeting affirms or changes the work of the virtual meetings.



Plenary session (the whole assembly) acts upon affirmed petitions. They are incorporated in an updated *Book of Doctrines and Discipline*.

# Credentialing/Registration REGISTERING WHEN YOU ARRIVE IN SAN JOSE

Our Credentialing/Registration Team looks forward to welcoming and serving you at this historic event. After you arrive in San Jose, you will need to check in with our Credentialing/Registration Team to receive your credentials for the Convening General Conference.

At check in you will receive a commemorative badge and lanyard for identification, and a colored wristband. You must present the Credentialing/ Registration Team your passport (or Costa Rican ID) and a copy of your unique QR code that was sent to you at registration, in order to receive your ID badge and wristband. Your ID Badge will give you access to the shuttle busses, to every General Conference session, and to all off-site worship services. The ID Badge includes: your name, position, your annual conference or sponsoring group, and QR codes with conference and delegate information. We know that many of you have multiple responsibilities, but you will only have one title listed and it will be the most relevant role for the Convening General Conference. For example, the most relevant position you can hold is that of delegate, even if you are also a President Pro Tempore or member of the Transitional Leadership Council.

At registration, a security type wristband will be attached on your wrist and should not be removed for the duration of the conference. This band will be shown to the Marshalls at the entrance to all events, and all secured areas. The color of your wrist band determines the level of your access. The access categories are: Business, Bar (Delegate, Alternate, and Administrative), Stage (Full and Daily), and Observer. It is essential that you wear your ID Badge and wrist band to all conference events. Loss of your ID Badge or wristband will require you to re-register at the Credentialing desk.

It is **strongly encouraged** that you check in prior to the morning of September 20th, so that there are no delays in you being able to fully participate in the Convening General Conference. Please read the following carefully, so that you know where and when to check in:

 Volunteer and Leadership Teams with pre-conference meetings/orientations scheduled for September 18th and 19th will be checked in at the CCCR Registration Area (or your designated meeting place) when your team first meets. This includes Registration, Hospitality, Marshals, Pages, Sponsors, President Pro Tempores, Transitional Commission on the Convening General Conference, Transitional Leadership Council, Voting System Support, Prayer Team, and participants in the Worship rehearsal at CCCR.

- Check in will be available for all delegates, alternates, and other participants
  throughout the day on September 19th at a conference hotel. The Registration Team
  will have volunteers available at check in tables near the hotel registration desk,
  and marked with Global Methodist table runners. These are the times that volunteer
  teams will be available:
  - DoubleTree Convention Center, Wyndham Convention Center, Marriott, and Wyndham Garden Escazu — 10:00am-8:00pm
  - Hilton La Sabana, Hilton Garden La Sabana, and Crowne Plaza 1:00pm-8:00pm.
  - NOTE: Guests staying at Hilton La Sabana and Hilton Garden Inn will both check in with our team on the 1st floor of the Hilton Garden Inn by the Tour Desk.
- Starting on September 20th, all registration will take place at CCCR in the area marked for Registration. The Registration Desk will open at 7:00am each day, and will remain open during normal conference hours with the exception of any scheduled worship services. Registration will close down 10 minutes prior to all times of worship, including Opening Worship on September 20th, which is why it is important to make sure you check in as soon as possible in order to not miss any of this historic occasion.
- Also, beginning on September 20th, there will be a Credentialing table in the main conference area, for any questions or concerns around credentialing, seating alternates, or other issues.

If you are a delegate, your ID Badge and wristband will give you access to the bar of the conference. Alternates will also have access to the bar of the conference, but will only need to be within the bar, when they are assigned to fill in for a seated delegate. When a delegate needs to be substituted for any reason, the Delegation Head will follow the process provided by the Credentialing Team to manage the seating of an alternate and the reseating of the delegate (if needed).



# **Meal Plans and Instructions**

# MEAL INFORMATION FOR THE CONVENING GENERAL CONFERENCE

Food trucks will be available on-site for lunch and dinner, offering a range of options priced between \$7 to \$15. Delegates, alternates, staff, and volunteers who are in session and unable to visit the food trucks will receive boxed meals. Badge verification will be required for those receiving boxed lunches, and allergy-friendly options will be provided upon request.

There is also a small café at the conference center with items available for purchase, and a snack station will be set up for added convenience. If you have specific dietary restrictions or needs beyond what is provided, please plan accordingly.

# Transportation Logistics for the global methodist church delegates and guests

To help ensure your travels are as smooth as possible, here are the detailed transportation arrangements for shuttles between your hotels and the conference venue, as well as airport transfers.

# DAILY SHUTTLE SERVICE

#### **MORNING SHUTTLES**

- Early Bird Shuttle: Departs from each hotel at 6:00 AM for those with early shifts or meetings.
- Regular Shuttle: Departs from each hotel at 6:30 AM for most attendees.

To ensure you do not miss your shuttle, please arrive 5 minutes before the departure time. If you miss the shuttle, you will need to arrange alternate transportation via taxi or Uber, both of which work smoothly in Costa Rica.

### MID-DAY SHUTTLE (FOR VOLUNTEERS/WORKERS ONLY)

- Departure from hotels: 11:00 AM
- Departure from the CCCR back to hotels: 1:30 PM
  - Note: Mid-day shuttles will only run September 20-25, NOT on the 26th.
  - There will be a third mid-day shuttle that will bring people from hotels to the CCCR about half an hour before dinner. This shuttle will not always depart at the same time on each date.

### **EVENING SHUTTLE (DEPARTURE TIMES)**

The departure times for evening shuttles from the CCCR will vary based on the Legislative Committee's schedule, which will be announced daily (potentially with a two-hour notice). Please stay informed of updates each day:

- No evening session: Buses will depart at 7:30 PM from the CCCR to the hotels.
- Evening session scheduled: Buses will depart at 9:45 PM from the CCCR to the hotels.
  - **Note:** On the nights of September 21, 22, and/or 23, due to potential differences in legislative committee decisions about evening meetings, it is possible that one part of the conference will leave the CCCR at 7:30 PM while another portion will leave at 9:45 PM. The shuttles at both times will have plenty of room for non-delegates.

# AIRPORT SHUTTLE SERVICE

#### **ARRIVALS**

- Before September 17: Attendees arriving before this date will need to arrange their own transportation to their hotel (Uber/taxi services are available).
- On September 17 and beyond: Look for GMC volunteers wearing yellow-green vests at the airport, who will be holding signs to direct you. They have access to flight manifests and your hotel information, but please confirm your hotel with them to ensure you are guided to the correct shuttle. Your shuttle will depart within two hours of your arrival to allow time for customs and baggage claim.

#### **DEPARTURES**

Shuttles will be scheduled for departure to the airport on September 27 and 28
based on flight manifests. The goal is to have you arrive at the airport at least three
hours before your scheduled flight. These departure times will be announced soon
and sent via email.

## SPECIAL PRE-CONFERENCE MEETINGS

• For attendees participating in any **pre-conference meetings**, please be aware that **official shuttle service will not be guaranteed** for these events. We encourage you to coordinate ridesharing with other participants at your hotel, if possible. You may be able to ride together in someone's rental car or arrange for a shared Uber or Didi ride to the location of the meeting. This is the most efficient way to ensure you arrive at your pre-conference meeting on time.

# **IMPORTANT REMINDERS**



# Know Before You Go: RECOMMENDATIONS FOR TRAVELING TO COSTA RICA

Joining us in Costa Rica for the convening General Conference? Here are some recommendations to help you prepare for your travels and your time in the beautiful country.

# **HEALTH AND SAFETY**

- **Vaccinations:** It's recommended to be up to date on routine vaccines before traveling. Additional vaccinations may be advised. Check the latest guidelines here.
- Medications: Bring a sufficient supply of your medications. Carry prescription
  medications in their original packaging and if possible, with your doctor's prescription.
- **Digestive Health:** Consider obtaining an over-the-counter antibiotic to address any potential stomach issues that may arise during your trip.
- **Drinking Water**: Water in Costa Rica is safe to drink. However, if you are concerned, bring bottled water. If you are drinking Costa Rica's water it's recommended to bring a refillable water bottle to use throughout your travels.
- Pharmacv:
  - Farmacia Ciudad Cariari is a 10 minute walk from CCCR.
  - Farmacia Real Cariari is a 21 minute walk from CCCR.
- **Medical Personnel**: Each of the venues will have two ambulances staffed not only to transport people to care facilities but to treat a range of issues from first aid to more serious conditions on site. Should there be a need for someone to be transported to a local hospital, we are currently working with our physician contact at the Clinica Biblica, Dr. John Longworth.
- Urgent Care: Emergencias. Phone is 506-2290-4444. It's a 12 minute drive from CCCR.

• **Hospital:** While there are hospitals closer to the CCCR that may be available in cases of extreme emergency, the following two hospitals are known to work with foreign health insurance carriers and are therefore recommended to Conference attendees:

# **CONTINGENCY/EMERGENCY PLANS**

There is an Info desk on site at the CCCR staffed with two workers and two roaming throughout the site with yellow vests and blue fanny packs. You can also find them at the airport and your hotel for your assistance.



- **Security:** There will be multiple security staffed every day during the conference. They will float around the convention center, making sure everything is okay. They can help offer basic assistance to attendees such as giving directions. They can also help step in if a violent situation arises, as well as contact the police as needed.
- Police: Police typically patrol around the outside of the convention center for big events. If needed, you can call local police and they will arrive within 10 minutes.
   Same for ambulances.
- Methodist School: We will have a CR Methodist Church/School "hospitality team" welcoming as attendees arrive at the school on the afternoon of the 20th. There will be at least one guide/bus preparing the passengers for what they can expect (including a map of the school) on the 45 minute/1 hour ride to the Methodist School. Once there, the buses will unload passengers in the lower parking lot and immediately exit, allowing additional buses to enter. Most people will either climb steps or a fairly steep sidewalk to the dining areas. However, the Methodist School will have contracted three or four smaller buses (20 passengers) to take persons up the hill should they need assistance.

# **SAFETY PRECAUTIONS**

- **U.S. State Department STEP Program:** We recommend enrolling in the <u>Smart Traveler Enrollment Program (STEP)</u> to receive important safety updates from the Embassy about conditions in Costa Rica.
- Personal Safety: Keep your belongings secure, especially in crowded areas. Avoid displaying valuables and be cautious when using ATMs.
- Accessibility: For travelers with accessibility issues, it's recommended to bring your own wheelchair to ensure availability and comfort during your trip.

## FINANCIAL TIPS

- Credit Cards: Major credit cards (Visa, MasterCard, American Express) are widely accepted at hotels, restaurants, and larger stores. Food trucks will accept Visa, MasterCard, or AmEx. Small vendors may only accept cash.
- ATMs: ATMs are available in cities and towns. Look for machines connected to international networks such as Cirrus, Plus, and MasterCard.
- Currency: The official currency is the Costa Rican colón. It's a good idea to have some local currency for small purchases. <u>Visit the currency converter website</u>.

# TRAVEL INSURANCE

• **Insurance Recommendations**: We highly recommend getting travel insurance to cover unexpected medical expenses, trip cancellations, and other potential issues. Americans should consider comprehensive travel insurance, while international travelers should consult their local providers for suitable options.

# **ELECTRICAL INFORMATION**

• **Electrical Plugs**: Costa Rica uses the same electrical outlets as the United States (120V, 60Hz). No need for a power adapter if you're coming from the U.S.

# COMMUNICATION

• International Calling Plans: To avoid high roaming charges, consider purchasing an international calling plan or a local SIM card for your phone. If a local SIM card is

needed, there are ways to purchase them before even departing the airport. Check with your carrier for information. Put your phone on airplane mode if you wish to avoid charges, just know you will be cut off from cell networks.

- Language: Spanish is the official language of Costa Rica. While many people in tourist areas speak English, there are areas where that might not be the case. We recommend learning a few basic phrases that could assist in this or if feasible, securing an app that provides a platform to assist in translation between your native language and Spanish. We recommend <a href="Google Translate">Google Translate</a> either through the app or web.
- **The app:** Wordly will be used during sessions. Have <u>Wordly</u> downloaded on your phone and keep it running as much as possible for it to work better. You can use the app or web version, however, we recommend the app.
- Charging: Bring your own remote charging brick to avoid your phone dying.
   Wordly will drain your phone quickly.
- **Headphones:** These will need to be used when using Wordly. We will provide headphones. Still, feel free to bring your own.

# **TRANSPORTATION**

- **Driving:** If you plan to rent a car, be aware that driving in Costa Rica can be challenging due to road conditions and local driving habits. Traffic can be heavy and should be considered in planning to prevent possible delays.
- Ride Sharing: Services like Uber and Didi operate in major cities and can be a convenient and safe option for getting around.
- **Bus:** The hotels to be used during the Annual Convention activity to which is assigned a number, are:
  - 1. Marriott Costa Rica Hacienda Belén
  - 2. Wyndham San Jose Herradura Hotel
  - 3. Doubletree by Hilton Hotel Cariari
  - 4. Hotel Crowne Plaza San José La Sabana
  - 5. Hilton San José La Sabana
  - 6. Hilton Garden Inn San Jose La Saban

Be sure to print out your registration bar code and have it ready to show to the busses.

On the early-bird shuttle please be sure that those that need to be at the CCCR at a particular time have a spot. This shuttle is intended for our workers.

## **WEATHER IN SEPTEMBER**

September is part of the rainy season in Costa Rica. Be prepared for frequent rain showers and possible thunderstorms. It's advisable to pack a waterproof jacket, an umbrella, and quick-drying clothes.

## **PROPER APPAREL**

Business casual attire is recommended. This includes comfortable yet professional clothing, such as slacks, blouses, polo shirts, and dresses. Blazers are optional, and ties are not required. Bring comfortable walking shoes. Lightweight, breathable fabrics are recommended. Keep in mind that this time of year is the rainy season in Costa Rica, so we suggest bringing a light jacket or umbrella. Additionally, conference center temperatures can be cool, so you might want to layer your clothing for added comfort.

- Fresh Market Ulloa is a 9 minute walk from CCCR.
- Uni Súper Heredia is a 20 minute walk from CCCR.
